<u>Observation Introduction</u>: Provide your name, date of the goshawk observation, approximate time of day and the county where the goshawk was observed in the first row of blocks. In the second row of blocks please provide your e-mail address AND phone number so that technical committee members can contact you if there are any questions. It is essential that committee members, and/or field verifiers be able to contact you if they need further information to complete verification of your observation. Please also include any area name, such as state forest, state park, state game land, etc. that might be useful in the general location of your observation.

<u>Observation Details</u>: Precise location information is essential. Please use a smart phone GPS app, handheld GPS, or Google Maps to determine the latitude and longitude of your observation as accurately as possible. Instructions for how to determine coordinates on-line can be found at the web site referenced on the bottom of the front of this form. Indicate species by checking Northern Goshawk or crossing out Northern Goshawk and writing in the species in the lower section of the box. Please also circle the type of land ownership in the final box.

<u>Property Information</u>: Provide landowner contact information, this is particularly important for observations located on private land were land access permission will be needed to verify your observation.

<u>Observation Classification</u>: Place an X in the <u>most appropriate</u> box(s) that describes the behavior of the goshawk (or other hawk species). This will help technical committee members evaluate your observation and assist with verification.

<u>Your Observation</u>: Please fully describe your observation, including the goshawk's behavior, calls, nest, chicks, etc. For documentation and verification purposes, whenever possible, obtain and submit photos of the nest and/or the hawk itself. Cell phone images are acceptable. If you have a smartphone you can record and submit vocalizations of the nesting hawk. Providing images, and/or recordings of vocalizations, will greatly assist with verification of your observation.
